Guidelines for HF Grant Application

Grant applicants may be the following: HF teachers, grade-level teams, groups, organizations, and/or subject departments

Award of Funds: Grants are for \$750 each. Two (2) grants of \$750 each will be awarded per campus.

Selection criteria:

1. The degree to which the proposal represents creative or innovative approaches to instruction.
2. The degree to which the proposal develops, supports, or promotes academic excellence.
3. The degree to which the project and the objectives, teaching methods, time schedule for implementation, and evaluation of project are clearly defined.
4. The degree to which student learning is directly impacted.

Our intent and understanding is that the materials/equipment awarded will be for long-term benefit of the students and will become property of HFISD.

Selection process:

1. Application forms can be obtained on-line at www.hfisd.net (under administration) or at the campus office.
2. Applications at the campus level must be signed by the principal.
3. Signed applications are due by the specified date on the application.
4. Applications will be presented to the grant committee without names of the person(s) requesting the grant.
5. A summary of the projects selected by the HF Grant Committee will be submitted to the board for approval. Projects selected will be kept confidential until the date that the grants are awarded to the recipients.

6. Materials and/or equipment will be ordered by the HF Education Foundation in cooperation with administration.
7. Recipients will be recognized at each individual campus.

Responsibility of the Grant Recipients:

1. Use the funds for the purposes intended.
2. All materials will remain the property of HFISD if the awarded teacher leaves the district.

Due Date: Dates for announcing availability of grants, evaluating applications, closing dates for application and awarding grants will be recommended by the Grant Committee and approved by the HF Foundation Board. Applications must be received by the date specified on the application.
